JRUUC Last-to-Leave Procedure

Draft update April 2015

- → Ask out loud if anyone else is in the building.
- → Confirm that the Administrative Office and Staff Office doors are closed and locked.
- → Confirm that no one is left in the building.
- → Close Fire Doors.
- → Confirm all exit doors are locked by physically checking each door.
 - ◆ Johnson Street Door (front door)
 - Lock this door by inserting pen/key into the hole located on the metal push bar's underside. You will hear a click and the bar will release if it was locked.
 - ◆ 4th Street Door (parking lot shared with 4&20 Bakery & Milio's)
 - This door should remain locked at all times.
 - Sanctuary Door (off Sanctuary and lead to back parking lot)
 - This door should remain locked at all times.
 - ◆ Storage Room Door (leads to back parking lot)
 - This door should remain locked at all times.
- → Turn off all lights.
- → Confirm all faucets are turned off. There are 4 bathrooms and 1 kitchen.
- → Thermostats: There are 4 thermostats
 - ◆ 2 in the Sanctuary on each column by the entrance door.
 - ◆ 1 is in the Lobby by the front hallway.
 - ◆ 1 is in the rear hallway by the men's bathroom/storage room door.
 - ◆ All thermostats operate on a programmed schedule during regular building usage.
 - IF the last to leave is done during regular building usage hours, the thermostats shouldn't require intervention.
 - IF the last to leave is done outside of regular building usage hours, and the thermostat has been changed/adjusted, please press "CANCEL" (lower right) and the thermostat will reset to the original program.
 - You will need to do this for each thermostat that has been changed or adjusted.
